ENTRY REQUIREMENTS

To be admitted to the Master's Degree in Family Business Management, the applicant is required to:

- Hold a Bachelor's Degree or equivalent degree recognized by the Ministry of Education, Youth and Sports.
- Have at least 3 years of work experience after obtaining a degree or equivalent degree recognized by the Ministry of Education, Youth and Sports.
- Pass at least two subjects of the entrance exam: English and the specialized subject.
